



Conas a dhéanfaimid deileáil le hiompar bulaíochta – Achoimre an-ghairid.

(How we deal with bullying behaviour – A Very short summary)

Ó 2013 tá córas Seán Fallon (Back Through the cloud of Bullying) in úsáid ag S.N. na Rinne le deileáil le cásanna bulaíochta, cosúil le an-chuid scoileanna sa tír fuaireamr go bhfuil an córas seo thar a bheith éifeachtach. Níor bhris éinne inár scoil an chéad nóta gealltanais fós. Seo thíos achoimre gairid den gcóras. Since 2013, S.N. na Rinne has been using the Seán Fallon system (Back Through the Cloud of Bullying) to deal with bullying cases, and, like many schools in the country, we have found that this system is extremely effective. No one at our school has ever broken the first promissory note. Below is a very brief summary of the system.

1. Nuair a dheimhnítear bulaíocht (When bullying is confirmed)

- Déanann an múinteoir “Seicliosta ar Iompar Bulaíochta” leis an dalta a rinne bulaíocht chomh luath agus is féidir.
The teacher uses a “Bullying Behavior Checklist” with the child who bullied, as soon as possible.

2. An chéad Gealltanais (“Foirm Gealltanais”)

(First Promise – “Form of Promise”)

- Tugtar deis don dalta gealltanais a shíniú nach ndéanfaidh sé/sí bulaíocht arís.
The child is offered the chance to sign a promise not to bully again.
- Má shíníonn siad, ní chuirfear tuismitheoirí ná an Príomhoide ar an eolas, agus ní chuirfear pionós orthu faoin gCód Iompar na Scoile.
If they agree, parents and the Principal are not informed, and no punishment from the school’s code of behaviour is applied.

3. Má bhristear an gealltanais (If the promise is broken)

- Tugtar rogha don dalta Foirm Gealltanais 2 a shíniú.
The child can choose to sign a second promise (“Form of Promise 2”).

- **An uair seo, cuirfear tuismitheoirí agus an Príomhoide ar an eolas, agus iarrfar ar thuismitheoirí síniú freisin.**
This time, parents and the Principal are informed, and parents are asked to sign too.
 - **Ní cuirfear pionós orthu má shínítear an fhoirm seo, ach má bhristear í, beidh pionós faoi Cód Iompar na Scoile i bhfeidhm.**
No punishment is given if they sign, but breaking this second promise can lead to sanctions under the school's behavior code.

4. Aidhm iomlán(Overall goal)

- **Spreagadh freagracht agus athrú iompraíochta, agus deis a thabhairt don dalta a gcuid gníomhartha a cheartú gan pionós láithreach.**
Encourage responsibility and change in behavior, while giving children a chance to correct their actions without immediate punishment.
- **Ma bhristear an tarna nóta gealltanais, deileáilfear leis an iompar faoi cód iompar na scoile.** *If the second promissory note is broken the behaviour will then be dealt with under the schools code of behaviour.*
